In accordance with Business and Professions Code (BPC) section 7410 and California Code of Regulations (CCR), title 16, section 974.2, the Committee will conduct informal citation review hearings for the matters listed on Attachment 1. Each appellant, or their appointed representative, may present written or oral evidence relating to the facts and circumstances relating to the citation issued for which the appellant submitted a timely appeal to the Committee.

The informal citation review hearings will be heard in numerical order pursuant to the Hearing No. assigned to each matter on Attachment 1. The Committee will not receive any written or oral evidence for a citation that is not listed on Attachment 1.

Failure of the appellant or the appellant's representative to appear before the Committee at the appointed time except when good cause is shown, shall cause the citation to become final, and there shall be no administrative appeal except as otherwise provided by law.
